

Technics “RASAI DENYUTAN DENGAN HADIAH MENARIK” Contest Terms & Conditions

Technics “Rasai Denyutan Dengan Hadiah Menarik” – Post & Win Contest (“Contest”) is organized by Panasonic Malaysia Sdn Bhd (“the Organizer”).

1.0 Eligibility
